

PREAMBLE

This «VAPEVENT» event has been established and will be managed and organized by sarl L&O événements. It will take place at a precise and given time.

Will be called USER anyone browsing our Internet site www.Vapeventparis.com

Will be called VISITOR anyone freely registering to obtain a badge on the Internet site or on site during the event.

Will be called ORGANIZER the SARL 'L&O événements' and any other company duly authorized by 'L&O événements'.

PURPOSE

These General Conditions of Use are reserved for holders of access badges obtained through free registration on the Internet or on site and apply to all the services proposed over the two days.

These General Conditions of Use intend to precise the rights and obligations of the parties within the registration process and the use of the badge proposed by the Organizer on the www.Vapeventparis.com site. These General Conditions are in force and applicable from the registration until the closure of Vapevent to the public, i.e. Monday 12 September 2016 at 6.30 p.m. when all the Visitors have left.

The User of the site reckons being informed of these General Conditions of Use of Badges before registering, understanding them and accepting them without any reserve.

HOW TO REGISTER AND BECOME A VISITOR

Registrations may be made on line on www.Vapeventparis.com from now on and until 12 September 2016 incl. for professionals. They may also be made on site on 11 & 12 September during the Event opening hours, until 30 minutes before the end of the Event.

To register, enter your personal data as requested when registering. The VISITOR declares he is a professional of the e-cigarette (vape), fully legally entitled to do so and of age (over 18).

The USER ensures the accuracy of the information given when registering. Otherwise the VISITOR will be directly expelled from the Event.

In order to obtain a badge the VISITOR shall accept the General Conditions of Use of the VAPEVENT Visitors Badges. The VISITOR reckons having been informed of these Conditions directly on the Internet site (www.Vapeventparis.com).

Once the order has been validated, a confirmation e-mail together with the badge (under pdf) will be sent to the address given. The ORGANIZER shall not be liable, in any way, in case of temporary or definitive impossibility of the VISITOR to access to his e-mails.

The VISITOR shall print the badge. This one shall be presented at the Vapevent entrance.

The ORGANIZER reserves his right to change or remove any information contained in the presentation of the trade show on the Vapevent Internet site and this without any prior notice. This right is also applicable to the registrations made before by the USERS and the VISITORS.

GENERAL CONDITIONS OF USE OF THE BADGES. LIABILITY OF VISITORS.

By obtaining a badge you become a visitor of the event and a user of the services proposed by the ORGANIZER. As a consequence the USER reckons having been informed of the fact that his agreement to the content of these General Conditions of Use does not need any handwritten signature on this document. The VISITOR may save or print these General Conditions: saving

and printing this document shall be his own responsibility, the acquisition of the badge being free of charge or not.

Should the VISITOR not accept these General Conditions, the VISITOR shall not use the badges proposed by Vapevent. Any use contrary to these Conditions shall be the only responsibility of the VISITOR.

The VISITOR acknowledges being informed of all these General Conditions of Use. He shall accept and respect them without any reserve and adopt an exemplary behavior without hindering the proper progress of the event, its image and/or the rules applying to the event.

Should these General Conditions of Badges Use not be respected, the use of the badge(s) shall be withheld by Vapevent in order to analyse the prejudice. Should there be any actual or voluntary damages, a full cancellation of the badge(s) used for the concerned person(s) shall result in the entrance to the event being forbidden, and this immediately; the VISITOR could be expelled by the security team.

The VISITOR declares being informed of the general and practical information mentioned on the Vapevent (www.Vapeventparis.com) site: opening days, opening hours and any other information concerning the use of the badge.

It is the VISITOR's responsibility, as well as the Exhibitor's one, to respect the rules and the advice about the use of the material and the tasting of the e-liquids. More precisely, during the event, tasting e-liquids with a nicotine rate other than 0mg shall not be advisable. However it is each VISITOR's responsibility to check the nicotine rate of each tasting proposed by the Exhibitor. Should this condition not be respected, either by the Exhibitor or by the Visitor, the Organizer shall not be liable in case of damages, whatever the nature of the damage.

A badge is personal and to be used by only one person. It is not transferable and not exchangeable. It is used to access to the event on 11 & 12 September 2016 by professionals, project managers, reviewers, bloggers or journalists. Shall be considered as a 'professional' any person who has a SIRET number and is interested in the Vape activities.

Access to the event is submitted to control of validity of your badge. This badge is valid only during the Vapevent place and date. To be valid this badge must be printed on a white A4 sheet, without any modification of the print format and of good quality. Badges partially printed, stained, damaged or illegible shall be considered as not valid and might be refused by the ORGANIZER. This one also reserves the right to accept or to refuse any other material, especially the electronic ones (mobiles, tablets). There will be a QR code on each badge. This code shall allow only one person to access to the event.

When controlled you shall have to produce a valid official identity card with a photo and a proof of your being a professional. Following this control you shall keep the badge with you until the end of the event.

It is forbidden to reproduce, duplicate, forge the badge in any manner whatsoever, subject to criminal proceedings. Likewise, obtaining a badge without being a professional shall be liable to criminal prosecution and to the cancellation of the badge.

Should the www.Vapeventparis.com site be unavailable for whatever reason, and should this prevent the issuance of the badge, the ORGANIZER shall not be responsible. The www.Vapeventparis.com site may be undergoing maintenance or the access to it may be partially or fully withheld at any time, without any prior notice.

The ORGANIZER reserves the right to refuse the registration of a USER or a VISITOR, for good reasons, without any prior notice and at any time.

The USER reckons knowing and accepting without any reserve that the ORGANIZER collects personal data for the exclusive running of the site and to optimize its services. The VISITOR, in addition, accepts that emails be sent to him in order to guarantee a proper functioning of the registrations. The data collected on this site will in no way be forwarded to third parties, others than the concerned partners. When the visitor uses the appointment service, he agrees the transfer of his e-mail to the exhibitors. They may be used to send emails in order to inform the registered persons about Vapevent or partners shows. The VISITOR may at any time request that his mail address be removed from the list of mailing campaigns by sending an email to contact@vapeventparis.com

The ORGANIZER shall not be liable for the non-reception of a badge or of an information should the USER have committed a voluntary or non-voluntary mistake when giving his personal data.

FORUM - SOCIAL NETWORKS - COMMUNICATION

Before, during or after the event the VISITOR shall never tarnish the Vapevent image on the social networks or forums without having informed the ORGANIZER and without having received any answer back.

INTELLECTUAL PROPERTY

The ORGANIZER is the owner of any copyrights on www.Vapeventparis.com. As such and in conformity with the international and national intellectual property regulations, any elements available on the site (photographs, images, logos, drawings, brands, texts, hyperlinks, slogans, sound elements) shall be the exclusive ownership of the ORGANIZER. Any reproduction or full or partial representation made without the agreement of the ORGANIZER shall be illegal and constitute a counterfeit sanctioned by law.

LIABILITY

The Web User reckons that the ORGANIZER shall not be liable because of any misuse of the web site.

The ORGANIZER does everything to offer the Web Users available tools and reliable information. The ORGANIZER shall not be liable in case of any damage, of whatever kind (bodily harm, health damage, accidental damage, material damage...).

HYPERLINKS

The creation of www.Vapeventparis.com hyperlinks which would refer to its website or one of its pages shall be authorized only with the prior written agreement of the ORGANIZER. The ORGANIZER shall not be liable for any hyperlink present on the www.Vapeventparis.com web site and referring to other web sites or to any other internet page.

FORCE MAJEURE - SPECIAL CASE OF THE E-CIGARETTE REGULATIONS

Neither Party shall have failed their obligations should they be prevented or hindered by a fortuitous event or a force majeure. Shall be fortuitous events or force majeure any unavoidable circumstances, beyond the Parties' control, which the Parties will not have been able to prevent, in spite of doing their best. The Party concerned by such circumstances shall inform the other Party within seven (7) business days from the date they learnt about the circumstances. Should the force majeure case make it impossible to open the event, no refund will be done. Are expressly considered as being force majeure cases or fortuitous events, the ones usually retained by the French law and courts : Unavailability of delivery and transportation facilities, earthquakes ; storms, floods, fires, lightening , absence of telecommunication networks or difficulties specific to telecommunication networks external to VISITORS .

The regulation about the e-cigarettes event being currently rather unclear the ORGANIZER shall not be liable should VAPEVENT be prevented to take place, even partially, or in restricted conditions, following a decision taken by the French authorities.

No refund of the expenses incurred shall be made in case of cancellation or modification.

APPLICABLE LAW

These General Conditions of Use are governed by French law, both in terms of basic rules and for the rules governing their form as well as for the language applicable to contractual relations between the parties. [...]

Should one of the provisions of these terms and conditions be null and void, the remaining provisions shall not be null and void.

In the event of any dispute the USER or the VISITOR shall not bring the case before the courts without, before, trying a special conciliation procedure aimed at an amicable settlement of the dispute. Only courts within the purview of our head office shall be competent.
